**PASSENGER CONTRACT: MITV Great Capitals Tour (Vienna & Prague): May 1 – 11, 2023\*\***

(\*\*Tour begins May 2 in Vienna)

GENERAL TERMS & CONDITIONS: Please read this agreement carefully before sending any money.

**COVID-19 VACCINE: Please be advised that The Grand Tour may require tour participants to provide proof of up-to-date vaccination for the Covid-19 virus, for the health and safety of all passengers. Protocols are currently in flux, and a preliminary determination will be made by December 1.**

**Tour Cost:** The price of the MITV Great Capitals Tour is \$6,590 per person, ground only. This price is based on double-occupancy, and a minimum of 18 persons. Single supplement is \$1240. See note under Accommodations on the reverse. Tour cost includes a \$500 tax-deductible contribution to Music in the Vineyards. The Great Capitals Tour is operated by The Grand Tour Travel Company (TGT), Peterborough, NH.

**Tour Cost Includes:** Nine (9) nights 5-star deluxe hotel accommodations in Vienna and Prague • Daily buffet breakfast • 3 dinners, 6 lunches, and 4-5 evening receptions, all including wine • Prime tickets to 4 major performances, depending on ticket availability • Two private concerts exclusively for the group • Private guided tours of principal sites in Vienna and Prague, and other locations by expert guides • Excursion from Vienna to the Wachau; excursion from Prague to Nelahozeves • Private wine tasting in the Wachau • Private motor coach transportation for all excursions mentioned in the itinerary • Private airport-hotel transfers in both cities • Private guides for all activities mentioned in the itinerary • Entrance fees for all scheduled museum and gallery visits • Services of MITV staff and TGT tour manager throughout the tour • All gratuities for meals, bus drivers, local guides and tour manager • Baggage handling for two pieces per person for hotel transfer • Travel tips and suggested reading & recording list • Maps of Vienna and Prague • Two MITV luggage tags

**Tour price does not include:** Single supplement of \$1240 • Travel to and from the destinations • Meals and activities not offered as part of the tour • Alcoholic beverages not part of tour included meals • Tips for hotel maids • Personal expenses and purchases • Personal and travel insurance

**Reservations and Method of Payment:** The deposit for the tour is \$1000 per person, and is first come, first served. Payment is accepted by check or money order made out to The Grand Tour, or credit card (Visa, MasterCard, or AMEX). *\$400 of the deposit is non-refundable.* Please complete the tour reservation form to accompany your payment, and mail to: MITV Great Capitals Tour, The Grand Tour, PO Box 274, Peterborough, NH 03458. Upon receipt of deposit, The Grand Tour will send a letter of confirmation and travel insurance information. Prior to departure, additional items of interest will be mailed to the participants. A pre-departure reception will be arranged and hosted by MITV for all participants. *Please note that tour participation is limited to 25 participants or as hotel space allows.*

**Final Payment:** The final balance must be received at The Grand Tour or MITV by Friday, March 3, 2023.

**Rates:** Prices quoted are based on fares in effect at the time of printing and are subject to change prior to departure due to below minimum participation. Participants will be notified of any such price increase at least 30 days prior to departure.

**Cancellations:** You are entitled to a full refund if the tour is cancelled by MITV or THE GRAND TOUR (TGT). If you should cancel, there is a non-refundable \$400 fee. The remaining balance (minus the \$400 fee) will be refunded according to the following schedule:

Before March 4, 2023:	100%
March 5 – 19, 2023:	50%
March 20 – April 1, 2023:	25%
After April 1, 2023:	0%

Notice of withdrawal from the tour must be communicated to TGT by e-mail: info@thegrandtour.com or fax 603-532-8851. All cancellations will be confirmed by The Grand Tour. Ticketed passengers must return unused tickets and any other negotiable vouchers for an applicable refund to be processed. No refund will be given for any passenger who, for any reason, does not arrive for either airline or vehicle departure. No refund will be made for features the passenger opts not to use. Once travel begins, any change made by a passenger is the responsibility of the passenger. Cancellation penalties caused by accident or illness to a passenger do not constitute waiver of applicable fees. Refunds will be processed within 90 days of receipt of cancellation notice. No person outside the group may participate in tour activities, including transportation and meals, unless he or she is admitted under the full tour cost.

**Itinerary or Program Modifications** While every effort will be made to adhere to the tour itinerary as planned, MITV and THE GRAND TOUR reserve the right to modify the itinerary or programs at their discretion as warranted by circumstances at the time of the tour, including the right to substitute hotels of similar quality. In the event of any changes, MITV and TGT will work to substitute programs of comparable value.

**Accommodations:** Hotels are chosen for comfort, location and character. Because some may be located in historic buildings, please be advised that not all rooms are alike and may differ in size. Specific room assignments are within the sole discretion of the hotel.

**Transportation:** Participants are responsible for booking air travel. The Grand Tour will help travelers with flight arrangements, if needed. Participants arriving or departing on other dates or from other destinations will be responsible for meeting up with the group in Vienna and for any fees incurred by these arrangements. Neither MITV nor The Grand Tour is

responsible for any expenses and/or damages incurred due to weather and/or flight delays. Any additional costs incurred outside of the set guidelines will be the sole financial responsibility of said traveler.

**Travel insurance:** As cancellation fees are strictly enforced, we strongly recommend for your protection that you purchase trip cancellation insurance. Travel insurance is also highly recommended in order to protect participants who must cancel or interrupt their trip due to illness or injury. Trip cancellation insurance is available, and information will be sent after your reservation is received.

**Responsibility:** The Grand Tour Travel Company, LLC, and Music in the Vineyards (MITV) and its and their employees, shareholders, subsidiaries, affiliates, officers, directors, trustees or successors, do not own or operate any entity which is to or does provide goods or services for your program including, for example, lodging facilities, airline, vessel, or other transportation companies, guides or guide services, local ground operators, providers or organizers of optional excursions, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, The Grand Tour and MITV are not liable for any negligent or willful act, failure to act, financial failure or other defaults of any such person, entity, supplier or any other third party.

In addition and without limitation, The Grand Tour and MITV are not responsible for any injury, financial or other loss, death, inconvenience, delay, or damage to person or property in connection with the provision of any goods or services whether resulting from, but not limited to, "acts of God" or force majeure, such as regarding the Covid-19 virus, acts or orders of government, denial or delay of entry into any country, acts of war or civil unrest, insurrection or revolt, bites from or attacks by animals, insects or pests, strikes or other labor activities, criminal or terrorist activities of any kind or the threat thereof, sickness, illness, epidemics or the threat thereof, quarantine, the lack of availability of or access to medical attention or the quality thereof, mechanical or other failure of airplanes, vessels or other means of transportation, or for any failure of any transportation mechanism to arrive or depart timely or safely. Further, all passengers release The

Grand Tour and MITV from its own negligence and assume all risk thereof.

If due to weather, flight schedules or other uncontrollable factors, you are required to spend an additional night(s), you will be responsible for your own hotel, transfers and meal costs. Further, MITV and The Grand Tour shall not be responsible for losses or additional expenses of the participant due to sickness, weather, flight schedules or other uncontrollable factors, strife, civil unrest, acts of terrorism, quarantine, "acts of God," loss of baggage, or other causes beyond their control. Neither MITV nor The Grand Tour is responsible for any expenses incurred regarding the Covid-19 virus, including but not limited to medical expenses, testing fees, quarantine, evacuation expenses, added air or hotel expense, etc., as a result thereof.

Under no circumstances is The Grand Tour obligated to refund the cost of any purchased travel insurance. The Grand Tour is not required to cancel any program for any reason including without limitation, United States Department of State, Centers for Disease Control, World Health Organization or other Warnings or Advisories of any kind. The Grand Tour is not responsible for fees assessed by air carriers resulting from operational and/or itinerary changes, even if The Grand Tour makes the flight arrangements or cancels the program. The Grand Tour reserves the right to substitute vessels, hotels or attractions of a similar category for those listed in this brochure.

**Miscellaneous:** The Grand Tour reserves the right to decline to accept or to retain any person as a member of the tour should the person's health, actions, or general deportment impede the operation of the tour or the rights or welfare of the other participants. No refund will be made for any unused portion of the tour. ***Please note that there is a moderate amount of walking on this tour.***

**Forum.** Any dispute regarding these terms and conditions or the trip itself must be brought only in courts in and for Peterborough, New Hampshire. For this specific purpose, the parties agree to personal jurisdiction and proper venue in such courts.
